All applicants for a peddlers and solicitors license in the Town of Van Buren are required to submit, at their cost, a background check which includes the following: National/State/County Criminal History and National Sex Offender Registry. This background check must be dated no more than 30 days prior to the date of the application.

Background checks must be submitted for anyone who will be going door to door with you or on your behalf.

Photo ID is also required for the applicant and anyone going door to door with the applicant or on your behalf.

Fees: All fees paid to the Town of Van Buren are non-refundable. Please make your checks payable to the Town of Van Buren:

15 Day License = \$25.00

30 Day License = \$30.00

Annual (1 year License) = \$100.00

What you need to know to go Door to Door in Van Buren

- ** No door to door calls before 9 am or after dusk
- ** No knocking or ringing a bell where there is a sign for “no soliciting”, “no peddlers” or “no agents”
- ** No soliciting within 200 feet of any public school
- ** No refusal to leave private property when asked to do so by owner

Failure to follow the rules for Peddling/Soliciting in Van Buren will result in revocation of license.
