Citizens Comments:

Mr. Nick Georgiades, 111 Clarewood Drive, said he wanted to confirm that the town will be fixing some backyard drainage issues at his house.

Mr. Hoy said yes, his property is on the schedule for this summer.

Mr. Georgiades also asked if a stop sign can be placed at the intersection of Delwood and Clarewood Drive.

Mr. Foster said the Board can look into adding this to our Code and then a sign can be placed there. He said he looked into this a couple years ago and NYS considers this a "T" intersection so it technically does not need a stop sign.

Mr. Sykes said the Board can add this intersection to the list when we do them for Marion Meadows.

Mr. Georgiades asked about the street sweeper leaving stones behind it and whether it needs repair.

Mr. Foster said the sweeper is very old and the town does contract with C & S to provide additional sweeping of town streets.

Mr. Sykes said a street sweeper is an item that could be jointly purchased with another municipality because of the high cost and easily shared since it can be used during the day and at night.

Mr. Georgiades also asked for a “children at play” sign on Clarewood Drive. Mr. Sykes said the Public Safety Committee can look into that sign placement.

Introduction of Local Law B of 2016 which amends town procurement policy to allow for best value purchasing:

089-16-039 MOTION BY Mr. Zaccaria introduced proposed Local Law No. B-2016, titled “A Local Law Amending Chapter 50, titled ‘Procurement Policy’ to Authorize Purchasing Based on Best Value and to Set Forth Requirements for ‘Piggybacking’ Purchases,” which Local Law would authorize the Town to have the authority to award purchase contracts on the basis of best value and sets forth requirements for piggybacking purchases, and made the following motion, which was seconded by Ms. Sabin, to wit:

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Van Buren, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQRA) with respect to the proposed enactment of said Local Law, with the result that the Town of Van Buren Town Board shall act as lead agency in this matter.

NOW, THEREFORE, it is

RESOLVED AND DETERMINED, that the adoption of said Local Law is a Type II action for purposes of environmental review under SEQRA thus concluding the environmental review process.

RESOLVED AND DETERMINED, that the Town Board conduct a public hearing as to the enactment of proposed Local Law No. B-2016 at the Van Buren Town Hall located at 7575 Van Buren Road, Baldwinsville, New York, on May 3, 2016 at 7:30 p.m. or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard.

Councilor Committee Reports and Comments:

Mr. Tupper pointed out the poster on the wall in the Boardroom that was created by Ms. Breakey, Town Historian, that has also been posted at the Erie Canal Trail.

Mr. Tupper said they held a Public Safety Committee meeting and had fire department representatives, a representative from the 911 Center, Sheriff's Dept., and Baldwinsville Ambulance.

Mr. Tupper said they discussed the Hoag Road bridge closure and the emergency officials agreed that changing the name of one side of the road makes sense to avoid confusion. He said this will have to be discussed with the homeowners.

Mr. Tupper said the Sheriff has added patrols for speed enforcement on West Dead Creek Road.

Mr. Tupper said the fire department representatives talked about the need for some dry hydrants and whether the town could help in construction. He said they also talked about having free smoke detectors available. They discussed using the Highway Department parking lot for new drivers to practice driving fire equipment.

Mr. Tupper said the ambulance corps representative discussed their budget constraints. He said they are not supported by tax dollars and rely on donations and insurance payments. He said many of the transports they do are for those without insurance, but, they still must respond even though they are not compensated.

Ms. Lesniak said they respond to 4,000 call a year and are in need of both donations and volunteers.

Highway Superintendent Comments:

Mr. Foster said he received a call from a resident on Buccaneer Bend who asked for a “children at play” sign. He said he will look into these signs for the neighborhoods. But, he cautioned, that many studies have shown that too much signage often causes drivers to ignore all signage.

Mr. Sykes said many times these signs give parents and the kids a false sense of security.
