Citizens Comments:

Mrs. Angel Sherpa, 505 Crandon Terrace, said her neighbors are not maintaining their easements and drainage swales. She said the weeds and bushes are taller than she is and the town needs to clean them out. She said she would rather not have her tax dollars spent to clean up neighbors' property. She asked if the town's property maintenance law can be used to enforce this and the cost passed on to the property owner.

Mr. Sykes said the town is currently working on more strict property maintenance regulations.

Mrs. Sherpa also complained about the grading of the road that was compromised after Suit Kote resurfaced it a few years ago. She said she now has standing water and ice in the winter at the end of her driveway. She said resurfacing the road or taking out the concrete gutters will not solve the problem. She said her neighborhood is 25 years old and should not be experiencing these issues.

Mr. Sykes said he will discuss this with the Code Enforcement Officer and Mr. Hoy and Mr. Foster to come up with solutions.

Mrs. Sandy Tokarz, 1602 Old Rt. 31 showed the Board members pictures of her neighbor's yard that is full of junk. She said she has discussed this with the Code Enforcement Officer and knows he is getting quotes for clean-up.

Mr. Sykes said he is aware of this and the first estimate was \$5,000 and the company wants the Sheriff's present if they are selected to clean up. He is waiting on a second estimate.

Mrs. Tokarz said she also understands permission from adjacent property owners to use their property to get to this backyard would be helpful. She said she has no problem with them using her backyard as long as they do not disturb the area where her septic is located.
