Adoption of Local Law C-2018:

143-18-030 The following resolution was offered by Mr. Dudzinski, who moved its adoption, seconded by Ms. Sabin to wit:

WHEREAS, pursuant to the provisions of the Municipal Home Rule Law, proposed Local Law C-2018, “A Local Law to Amend Chapter 186 of the Code of the Town of Van Buren, titled, ‘Vehicles and Traffic’ with respect to Stop Signs on Caserta Drive, Milan Way and San Marino Path and to Establish a 30 mph speed limit on all roads in the Marion Meadows Subdivision” was presented and introduced at a regular meeting of the Town Board of the Town of Van Buren held July 17, 2018; and

WHEREAS, a public hearing was held to consider said proposed Local Law No. C-2018 on August 7, 2018 by the Town Board of the Town of Van Buren and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Van Buren in its final form in the manner required by Section 20 of the Municipal Home Rule of the State of New York; and

WHEREAS, at its regular meeting held on July 17, 2018, this Board, as lead agency, determined it would act as lead agency pursuant to SEQR and further determined that the enactment of this Local Law is a Type II action pursuant to 6 N.Y.C.R.R. Part 617.5(c)(16)(20)(27) thus concluding the environmental review process; and

WHEREAS, it is in the public interest to enact said Proposed Local Law No. C-2018.

NOW, THEREFORE, it is

RESOLVED AND DETERMINED, that the Town Board of the Town of Van Buren, Onondaga County, New York, does hereby enact Proposed Local Law No. C-2018 as Local Law No. 3-2018 as follows:

**TOWN OF VAN BUREN
LOCAL LAW NO. 3-2018**

**A LOCAL LAW TO AMEND CHAPTER 186 OF THE CODE OF THE
TOWN OF VANBUREN TITLED “VEHICLES AND TRAFFIC” WITH
RESPECT TO STOP SIGNS ON CASERTA DRIVE, MILAN WAY**

**AND SAN MARINO PATH AND TO ESTABLISH A 30 MPH SPEED
LIMIT ON ALL ROADS IN THE MARION MEADOWS SUBDIVISION**

BE IT ENACTED by the Town Board of the Town of Van Buren that this local law amends Chapter 186 of the Code of the Town of Van Buren, as follows:

Section 1. As authorized by §186-11 of the Town of Van Buren Code, so that Article VII, titled “Schedules”, Schedule VIII – § 186-50 thereof, titled “Stop Intersections” is amended as follows:

Assessor's Report:

Ms. Golden gave the following update on office activities:

ENHANCED STAR CHANGES:

The 2018 budget changes included making Enhanced Star Income Verification mandatory beginning in 2019. Multiple forms are required in 2019 for Senior Citizen exemptions, Enhanced Star exemptions and the MANDATORY IVP form. We have decided not to mail the exemption forms with the school tax bills, because of these changes. Assessor's have the option to mail the IVP forms to ORPTS for input into the state database. We will be imputing the information directly into the database from the submitted forms. We decided that this would be the best approach and would better serve our senior property owners.

Grievance Day was held on Tuesday May 22 by appointment only. 23 appointments were scheduled during the morning and evening session. 8 were submitted as paperwork only.

To Date: One certiori filing has been received and no small claims have been filed.

Regular Town Board Meeting August 7, 2018

The State ORPTS confirmed on July 19, the 2018 final equalization rate for the Town of Van Buren at 100%.

The County completed next year processing on July 12 and work has begun on the 2019 assessment roll.

The state audit team completed their field work in Lysander on July 10th. They are completing their report and the draft report will be submitted to the Town of Lysander when finished.

The Town of Van Buren will be hosting the August Assessor's meeting/picnic at Van Buren Park on August 21 at noon. This has become an annual request by unanimous vote of the Onondaga County Assessors, due to the success of the picnic held in 2016.

Ms. Sabin asked how many properties received an assessment reduction after Grievance Day.

Ms. Golden said about 20% of applicants.

Ms. Dickman asked if seniors will receive the STAR exemption as a reduction on their property tax bills or if they will get a check from New York State.

Ms. Golden said as long as they stay in their home and have the STAR exemption it will come off the bill, but, if they move they will have to pay the full bill and get the check from the state.

Ms. Lesniak said the changes do not seem beneficial to property owners.

Comments from County Legislator:

Mr. Bush said the town should have received a letter from the County Executive's Office regarding money owed to the towns from the severity clause in the county snow plowing contract. He said he remembers when the town supervisors worked as a group to get a better contract from the County for the towns who plowed county roads and is happy to see this as a result of their hard work.

Mr. Bush said he has been in touch with all county agencies regarding the old Syroco property. He said right now Roth Steel is taking all the time and money available to the Industrial Development Agency, but he said he will keep at the issue. He said part of the concern on the part of any potential buyer is potential contamination.

Mr. Bush gave out a brochure on a literacy program that the County is very involved in and he would like to make sure County residents are aware of called the Imagination Library. He said

all children who are enrolled will receive a book a month from birth to age five at no cost. He encouraged people to sign up for the program.
