PLEASE TAKE NOTICE, that the Lakeside Fire District in accordance with a Resolution duly enacted on December 28, 2020 has called a special fire district election/mandatory referendum to be held in said Fire District on the 26th day of January 2021 at which there will be submitted to the qualified voters of the Fire District residing therein at said special fire district election/mandatory referendum the following proposition:

**RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE
LAKESIDE FIRE DISTRICT, ONONDAGA COUNTY, NEW YORK (“THE
DISTRICT”), AUTHORIZING THE PURCHASE OF A RESCUE PUMPER AT A
TOTAL ESTIMATED COST NOT TO EXCEED \$992,463.00; APPROPRIATING
SAID AMOUNT THEREFOR; AND AUTHORIZING THE FINANCING BY A
COMBINATION OF THE USE OF RESERVE FUNDS UP TO \$600,000.00 IN
ORDER TO OBTAIN A DISCOUNT OF \$33,168.00 AND BY ENTERING INTO AN
INSTALLMENT PURCHASE AGREEMENT FOR THE BALANCE OF THE
PURCHASE PRICE OF \$359,295.00 AT AN INTEREST RATE OF 2.97% TO BE
PAID OVER EIGHT (8) YEARS IN ANNUAL PAYMENTS OF \$51,121.06
INCLUSIVE OF INTEREST AND PRINCIPAL.**

DULY ADOPTED BY THE BOARD OF FIRE COMMISSIONERS OF THE LAKESIDE FIRE DISTRICT ON THE 28th DAY OF DECEMBER 2020 BE APPROVED?

And that said special fire district election/mandatory referendum will be held at the **Lakeside Fire Department 1002 State Fair Blvd. Syracuse, NY 13209** and that the polls at said election shall be opened at the hour 6:00 p.m. Eastern Standard Time and will be closed at the hour of 9:00 p.m. Eastern Standard Time, and the vote shall be taken upon the proposition by paper ballot in the manner provided by law.

Those persons qualified to vote on the aforesaid proposition are those qualified voters who shall have resided in the Lakeside Fire District for at least thirty (30) days preceding the election.
